



b) Student may submit Remarking request by following the steps as shown below:

- 1) Apply via https://info365.uniten.edu.my/info365 > Academic > Results > Semester 1/Trimester 1,2023/2024> Tick box remarks (you can apply more than 1 appeal)
- 2) Make processing fees payment of RM100/subject via Initiate i-Pay/Flywire. Please take note your appeal to review final examination grade WILL ONLY BE PROCESSED upon receipt of your payment.
- The deadline for submission is on 26 February 2024 before 5.00 pm (Monday).

4) You may check result of application via email after getting Dean's Approval.



- c) Student with Terminated Status may appeal to continue studies by following the steps as shown below:
 - 1) Fill in https://info365.uniten.edu.my/info365 Log in > click I want to appeal for Reinstatement to UNITEN.
 - 2) Make processing payment amount of RM75.00 via Initiate i-Pay/Flywire. Please take note your appeal to continue studies WILL ONLY BE PROCESSED upon receipt of your payment.
 - 3) The Deadline for submission of the Appeal Form is on 26 Feb 2024 before 5.00 pm (Monday).
 - 4) You may check result of appeal application via email after getting Senate approval

- Student can only appeal not more than two (2) times consecutively.
